

ANNOUNCEMENT TO PREQUALIFIED BIDDERS

Subject to conditions prescribed by the University of California, Irvine Medical Center, sealed bids for a Lump-Sum Contract are invited for the following project: **Brea, ENT & Ophthalmology Clinic, Project No. 994727.**

ESTIMATED CONSTRUCTION COST: \$2,100,000

LICENSE CLASS REQUIRED: B

PROJECT DURATION: 90 calendar days

GENERAL DESCRIPTION OF WORK: The project consists of modifications to an existing clinic to convert to an OSHPD 3 clinic for ENT and Ophthalmology specialties. The project will convert existing support space to create necessary rooms, such as Dirty/Clean Scope Processing rooms, Clean Utility and Soiled Utility, Laser Room, Audio Booth Room, Med Stations, and other Ophthalmology testing rooms. Additionally, the project will replace all exam room doors to barn style doors, create a Practice Manager. Office and EVS Storage Room.

The project shall include minor demolition, wall construction, plumbing, electrical, lighting, HVAC modifications to comply with OSHPD 3 requirements, doors and hardware, flooring, ceilings, paint, and other finishes.
